



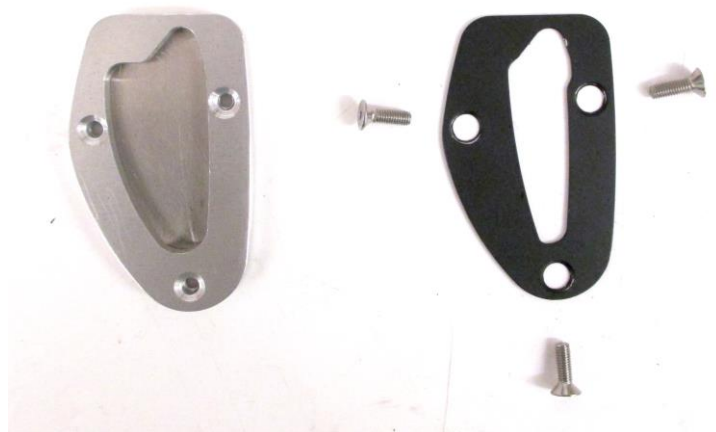
**FITTING INSTRUCTIONS FOR PKS0069SI KICKSTAND SHOE**  
**HONDA CBR1000RR '08-**



**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike.**

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*



**BASE PLATE**

**CLAMP PLATE AND BOLTS**

**TOOLS REQUIRED**

- 3mm A/F Allen key.

**FITTING INSTRUCTIONS**

- Take the clamp plate and feed it over the base of the side stand, with the countersunk holes facing upwards and position it around the side stand leg.
- Offer the base plate up to the underside of the side stand base.

- Apply a small amount (one drop) of Loctite Blue 242 to the end of the threaded area of each screw.
- Fit the three M5 bolts clamping the two plates together and securely mount onto the side stand foot.
- Tighten all bolts evenly and check to ensure the side stand pad clears the chain when in the raised position.
- If fitting to older stands that have been worn the padding strip should be placed in the base plate to ensure a tighter fit.

**Outils requis**

- Clé Allen 3mm

**INSTRUCTIONS DE MONTAGE**

- Prendre la plaque d'attache et placer la autour de la base de la béquille, avec les trous fraisés vers le haut et positionner la autour de la branche de béquille latérale.
- Placer la plaque au dessous de la base de béquille latérale.

- Appliquer un peu de colle Loctite Bleu 242 sur l'extrémité du filetage de chaque vis.
- Insérer les 3 boulons M5 verrouillant les 2 plaques ensemble puis monter en toute sécurité sur le pied de béquille latérale.
- Serrer tous les boulons de façon égale et assurez vous que le support de béquille soit espacé de la chaîne lorsqu'elle est dans la position relevée.
- Si l'installation se fait sur une béquille ancienne assez usée, la bande de rembourrage doit être placée dans la base plate afin d'assurer un ajustement plus serré.
